1. Apologies

- 2. Minutes of last meeting and matters arising
- 2.1 The meeting started at 7:00 pm in the Council Chamber, Clayport Street, Alnwick. Minutes of meeting 19 June 2012 were agreed as a true record.
- 2.2 Further to the item in the previous minutes Dave Chetwyn from Urban Vision, representing 'Locality' was introduced to the meeting.
- 2.3 It was noted that no letter had yet been received from Denwick Parish Council to officially confirm their resolution to join Alnwick Town Council in preparing a Neighbourhood Plan. **Peter Biggers and /or Cllr Taylor to contact the parish Council**.

3. Community engagement / stakeholder workshop dry-run

- 3.1 The business of the evening was set aside to allow a dry-run for the stakeholder workshop to be held on Tuesday, 24 July, 2012. NCC staff would be available at the event to take notes at several tables but more assistance would be required.
- 3.2 Chris Anderson from Plangle explained that, while it was unusual to have a dry-run it would enable the Steering Group, who would be facilitating, to understand and approve the facilitators' notes and proposed programme. He then ran through the programme answering questions as he progressed.

4.1 Dave Chetwyn offered Locality support identified as provision of a training session on writing plans. Unfortunately, because the programme's budget ends at the end of July 2012, he could only offer two potential dates: Wednesday 25, July or Monday 30, July. It was agreed that because the first date would be the day after the workshop the Steering Group would prefer to take up the 2nd training date. Dave will arrange this with Peter Biggers and Bill Batey for 6:30to 8:30pm in the Council Chambers or side room.
